13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. The proposal to abate Written Order Number 20MH009W is as follows: Upon approval, the current berm on the east side of location, approximately 250' in length, angling towards the north and ending at poly flowlines, will be reconstructed to prevent further erosion due to rainwater runoff. An additional berm, approximately 205' in length, will be built along the north edge of the well pad, and current eroded areas will be backfilled. This is also to aid in preventing runoff from the pad into the closed pit.

Visible plastic will be mechanically removed from the closed reserve pit area and clean, native topsoil will be added. It will then be recontoured, roughed and seeded with BLM mixture #4. The area will be annually assessed for growth, and reseeding will take place as needed until satisfactory growth has been achieved.
