POOH w/work string and RIH w/4" ported guns & perferd 7990'-7996', 8009'-8044', 8059'-8066', 8070'-8079', 8083'-8103', 8111'-8119', 8134'-8142', 8146'-8162', 8198'-8208', 8224'-8244', 8272'-8282', 8286'-8306' w/4 jspf in 11 runs. RIH w/7" PPI packers to 8306', dropped valves & PUH acidizing new perfs w/17% OCA sour acid @ 100 gpf for a total of 19,000 gals. Released PPI packers and POOH. RIH w/7" RBP, set & tested. RIH w/sub pump on 2-7/8" tubing and set RBP @ 8395'. Made final splice, installed tubing hanger in head, ND BOP & NU wellhead. Turned well over to production 5/20/03.
