05/02/06 Reached TD of 12-1/4" hole (2310'). Ran 9-5/8" 40# J-55 LTC casing to 2310'. Cemented with lead of 800 sx Interfill C (wt 11.9, yld 2.45) + 0.25# Flocele and tail of 200sx Premium Plus + 1% CaCl (wt 14.8, yld 1.33). Circulated 72 sx to pits. WOC 19.75 hours.  
05/03/06 Tested casing to 1000 psi for 30 minutes.
