4/17/06 Frac formation with 220,000 gallons of Aqua Frac 1000 + 135,500# White sand 20/40 + 24,500# Siberprop 16/30.

4/21/06 RIH with pump and rods. Hung well on production.

4/23/06 RDMO PU.
