4/20/06 RIH with RBP and set at 2895'. Tested plug to 1500 psi - ok. Dumped 2 sacks of sand on top of plug. POOH with tubing. RIH with casing gun and perforate San Andres formation from 2000-2761'; 34 holes. RIH with packer and set at 1912'.

4/21/06 Acidize formation with 3000 gallons 15% HCl. Released packer and POOH with tubing and packer.

4/24/06 Frac formation with 220,000 gallons Aqua Frac 1000 + 135,500# Brown sand 20/40 + 24,500# Siberprop 16/30.


4/25/06 RIH with tubing, pump, and rods.

4/28/06 Hung well on production. RDMO PU.
