- 4/17/06 Drilled and washed down to 5220'. Circulate hole clean.
- 4/18/06 Drilled out plug at 5222'. Clean out down to 6100'. Reached TD 6100' at 1:30 PM.
- 4/20/06 Set 5-1/2" 15.5# J-55 casing at 6100'. Cemented with 600 sx PVL (yld 1.41, wt 13). Float collar at 6057'. Tested casing to 1000 psi for 30 min.
