April 14, 2006: 15 hour SITP 2600 psig; 4-16-06: 15 hour SITP 2250 psig; 04-17-06: 39 hour SITP 2450 psig. 04-18-06: 15 hour SITP 1975 psig. Well flowed some gas and some water.
