03/20/06 Ran 60 jts 9-5/8" 40# J-55 LTC casing to 2650'. Cemented with lead of 625 sx Interfill C (wt 11.9, yld 2.45) + 0.25# flocele and tail of 200 sx Premium Plus (wt 14.8, yld 1.33) + 1% CaCl2. Circulated 236 sx to pit. WOC 19.75 hrs.
