5/13/06 Set 13-3/8" 48# H-40 ST&C casing at 860'. Cemented with 500 sx BJ Lite + 2% CaCl₂ + 1#/sx LCM-1 (yld 1.97, wt 12.5). Tailed in with 200 sx "C" + 2% CaCl₂ (yld 1.32, wt 14.8). Cement circulated to surface. Tested casing to 600 psi for 30 min. WOC 24 hrs. Reduced hole to 12-1/4" and resumed drilling.

5/20/06 Set 9-5/8" 36#, 40# J-55 casing at 3412'. Cemented with 1000 sx 35:65:6 Poz "C" + 5#/sx LCM-1 + 2% CaCl₂ (yld 1.98, wt 12.5). Tailed in with 200 sx "C" + 1% CaCl₂ (yld 1.34, wt 14.8). Cement circulated to surface. Tested casing to 1500 psi for 30 min. WOC 29 hrs 15 min. Reduced hole and resumed drilling.
