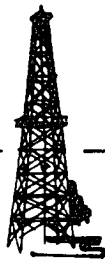

Harvey E. Yates Company (HEYCO) is the Operator of the Gates Federal Deep #1 well located on the captioned lease. In its original Form C-102, dated March 10, 1977, HEYCO designated the S/2 of Section 6 as the spacing and/or proration unit for this well.

OK → At this time, HEYCO requests your approval to change the spacing unit from a lay down S/2 to a standup E/2 configuration. All of Section 6 is within federal lease NM-0559532 and, since the working interest owners in this section have agreed to the change, none of the parties will be adversely affected.
