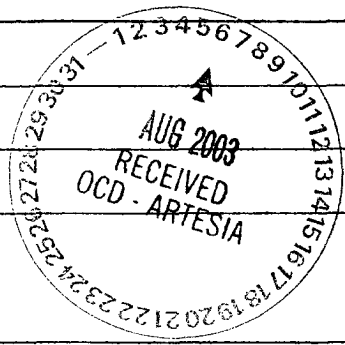

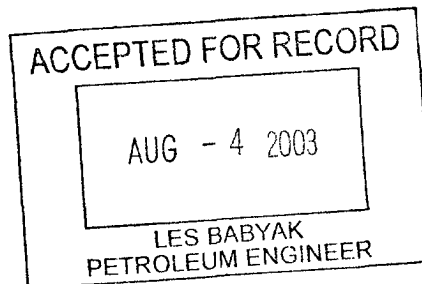

7-16-03: Moved in, rigged up rotary wireline to free point & cut tubing. Hot-oiled, tie on to tubing, pump down tubing, ran paraffin knife, working down. Tried to run wireline, release wireline crew, ran paraffin knife and swab mandrel on rods.
7-17-03: Freepoint/cut tubing @ 1950'. Pulled out of hole with 62.5 joints 2 3/8" tubing. Fishing. Go in hole with wash pipe.
7-19-03: Pick up overshot and collars. Go in hole to catch fish. Drilled to 2758', drilled scale and BSW from 2610-2739' reverse hole clean. Ran in hole with 86 joints 2 3/8" tubing, hang tubing on, nipple up wellhead. Start in hole with pump and rods.
Prep to put well on pump/production.
