Bass Enterprises Production Co. requests approval to alter the casing program as follows:

- Set 13-3/8" @ 500' and cement to surface (as approved).
- Set 9-5/8" @ 2900' and cement to surface instead of 2450' as approved.
- Set 5-1/2" casing @ 12,500' (TD) instead of 7" casing to 11,200' with 5" liner. Bring cement top 500' above uppermost hydrocarbon bearing interval.

If abnormal pressures are encountered prior to drilling the Morrow formation, a contingent 7" intermediate casing string will be utilized. If a production liner is required at PTD, it will be 4-1/2". Hole size from 2900' to TD will be 8-3/4" unless 7" casing is set.
