



Notify OCD of intent to TA wellbore.

- 1) MIRU PU. ND WH NU BOP. PU 2-7/8" workstring.
- 2) RU JSI to RIH w/ 5.8" gauge ring & JB w/ CCL to 7800'. PU & RIH w/7" CIBP and set @ +/- 7600'. Dump 35' cmt on CIBP. RD JSI.
- 4) PU & RIH w/2-7/8" tbg to pbtd. Circulate inhibited fluid to surface.
- 5) Pressure test csg to 500# for 30 min with OCD witness.
- 6) If test fails identify casing leak w/BP & pkr.

Clean location and notify OCD of change in status.

Well has uphole potential in the Glorieta/Yeso.
