Perforate from 6550' to 7300', 0.38", 48 holes.

Frac w/ 5520 bbls slick water; 72200 lbs 30/70 Brown sand; 242000 lbs 20/40 White sand; 12600 lbs 12/20 Super LC.

7/22/06 Perforate from 5400' to 6300', 0.38", 48 holes.

Frac w/ 5540 bbls slick water; 54600 lbs 30/70 Brown sand; 246600 lbs 20/40 White sand; 7200 lbs 12/20 Super LC.
