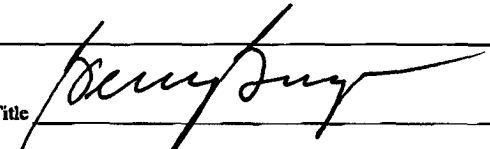

The Pogo 36 State #1 is an active salt water disposal, currently shut-in, that needs a temporary workover pit (approx 4' X 10' X 15') to repair a tubing leak. This pit will be emptied daily and will be located approx 10' west of the wellhead. Workover to commence immediately and take approximately 3 days. Received verbal approval to proceed. Pit will be removed after successful MIT. Remediation includes emptying, removing the liner, and covering. LOV NO. 027306
