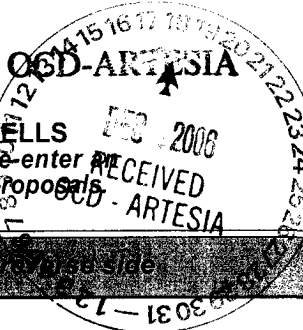

Tested BOPE to 3000# and annular to 1500#. At 1:00 am 11/23/06 tested 8 5/8" csg to 1250# for 30 mins, held OK. Tested formation to 11# MWE. Chart and schematic attached. Drilled out with 7 7/8" bit.
