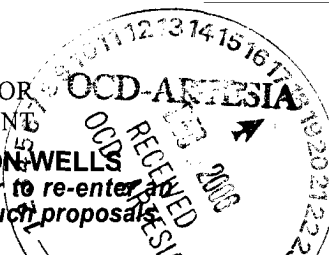

Tail with 500 sks Class H cement with additives. Mixed @ 15.1 #/g w/ 1.28 yd. Lift pressure at 1850# at 3 BPM. At 8:30 pm 11/18/06, tested 5 1/2" casing to 2300# for 30 mins, held OK. Set 140k on slips.

11/20/06...Released rig at 8:00 am 11/19/06.

12/05/06...Ran CBL and found TOC at 2700'.
