No well sign at well site. Violation Rule 103. Condensate leaking at stack pack. Violation Rule 13. Drilling pits open. Production casing was ran May 2005. Violation Rule 50. Unlined pit open on South side of drilling pits. Blow-down line terminates at this pit. Visible staining in pit. Violation Rule 50 and Rule 13. Well sign is to be installed no later than January 15, 2007. Work plan proposal for clean up of contaminated areas is to be submitted to NMOCD District 2 office no later than January 15, 2007. A form C-144 pit closure plan is to be submitted to the NMOCD District 2 office no later than January 15, 2007. Pit closure operations are to commence within 10 working days of OCD approval of closure plan.
