10/11/06 - Set 1st cement plug at 5592' with 75 sx Class "C" + 2% CaCl₂. WOC 2 hrs and tag top of plug at 5370'. Circulated hole with salt gel in 10# brine, 25#/bbl from 5370' up to 4200'. Set 2nd cement plug at 4584' with 75 sx Class "C" + 2% CaCl₂. WOC 2 hrs. Tagged plug at 4357'.

12/21/06 - TIH with work string and tagged at 4637'. Pumped plugging mud. Working pipe would not go down. Called OCD. Approved to spot 40 sx cement. WOC. Tagged at 4450'.

12/22/06 - Pumped 287 sx cement plug at 4147'. Pumped 287 sx cement plug at 3027'. Pumped 287 sx cement plug at 1907'.

12/26/06 - Tagged at 890'. Spotted 30 sx on top. WOC. Tagged at 780'. Spotted 25 sx cement from 60' circulating to surface. Cut off wellhead. Installed dry hole marker. **WELL IS PLUGGED AND ABANDONED. FINAL REPORT.**
