Pursuant to the recommendations of Mr. Wesley Ingram, Petroleum Engineer for the BLM, and Mr. Jerry Dutchover, Geologist for the BLM, in conversation dated December 14, 2006, BEPCO L.P., seeks permission to alter the casing program for the above captioned well. Due to the presence of the Capitan Reef and considerable salt sections to be drilled, the following casing plan is proposed:

30" Conductor Casing, 0 - 61' RKB (est.), Cement to surface.
20" 94 ppf K-55 Casing (26" hole), 0 - 950' RKB (est.), Cement to surface.
13-3/8" 54.5 ppf J-55 Casing (17-1/2" hole), 0 - 1,900' RKB (est.) Cement to surface.
9-5/8" 36 ppf K-55 Casing (12-1/4" hole), 0 - 3,100' RKB (est.) Cement to surface.
5-1/2" 17 ppf P-110 Casing (8-3/4" hole), 0 - 13,100' RKB, Cement to +/- 500' above Top of Bone Spring Formation.
