Yates Petroleum Corporation plans to workover and possibly plugback and recomple this well as follows: Stimulate current Morrow perforations. Set a composite plug or CIBP at 11,871' and perforate Morrow 11,764'-11,772' (49), 11,798'-11,820' (133) and 11,848'-11,852' (25). Stimulate as needed. Will consider turning the well to production or combining all productive Morrow intervals. If decision is made not to turn well to production, set a composite bridge plug at 11,714'. Perforate Atoka 11,200'-11,206' (37). Stimulate as needed. Set a composite bridge plug or CIBP at 11,150'. Perforate Strawn 10,954'-10,968' (29) and 10,998'-11,010' (25). Stimulate as needed.
