**Due to the potential of encountering overpressured gas bearing zones below 10,400', BEPCO, L.P. respectfully requests to alter the original well plan for the above captioned well in order to accomodate larger hole sizes and larger casing strings. The newly proposed casing design will include:**

**20" Conductor Casing, 0 - 61' RKB (est.), Cement to surface.**

**13-3/8" 48 ppf H-40 Casing (17-1/2" hole), 0 - 826' RKB, Cement to surface.**

**9-5/8" 36 - 40 ppf J-55 Casing (12-1/4" hole), 0 - 2,736' RKB, Cement to surface.**

**5-1/2" 17 ppf HCP-110 Casing (8-3/4" hole), 0 - 12,300' RKB, Cement to 500' above ICP (2,200' RKB est.)**
