Will set Model R injection packer or its equivalent approximately 100' above highest Paddock perforation.

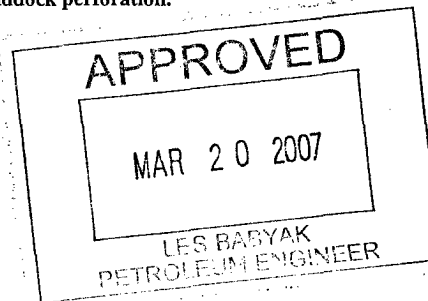
Will run 6.5# internally plastic coated tubing string.
