4/18/06 - Dressed off 5-1/2" casing stub. Ran 99 jts. 15.5 lb J-55 5-1/2" casing

4/23/06 - 4/24/06:

Drilled 5th plug from 6143' to 6490'. Drilled 6th plug from 8116' to 8519'. Drilled 7th plug from 9619' to 10,132'. Drilled to TD at 10,830'.
