Please amend the Indian Basin Field Commingle agreement as follows: Indian Hills Unit Gas Com #56 gross production will be sent to the same separator as the Indian Hills Unit Gas Com #27 at Station 120 Satellite Facility (see attached flow diagram). The #56 well will be piped into the test header with the wells from section 20, (these wells are Indian Hills Unit wells). When the #27 well is being tested, using the Indian Hills Gas Com Lease separator, the #56 well will be tested, using the test separator used to test the Indian Hills Unit wells. The wells from section 20 will all be sent to the Indian Hills Unit production separator during this test period so that the Indian Hills Gas Com production is not commingled with the Indian Hills Unit production. After being separated and measured, the production from this well will be handled as shown in the original commingle agreement. 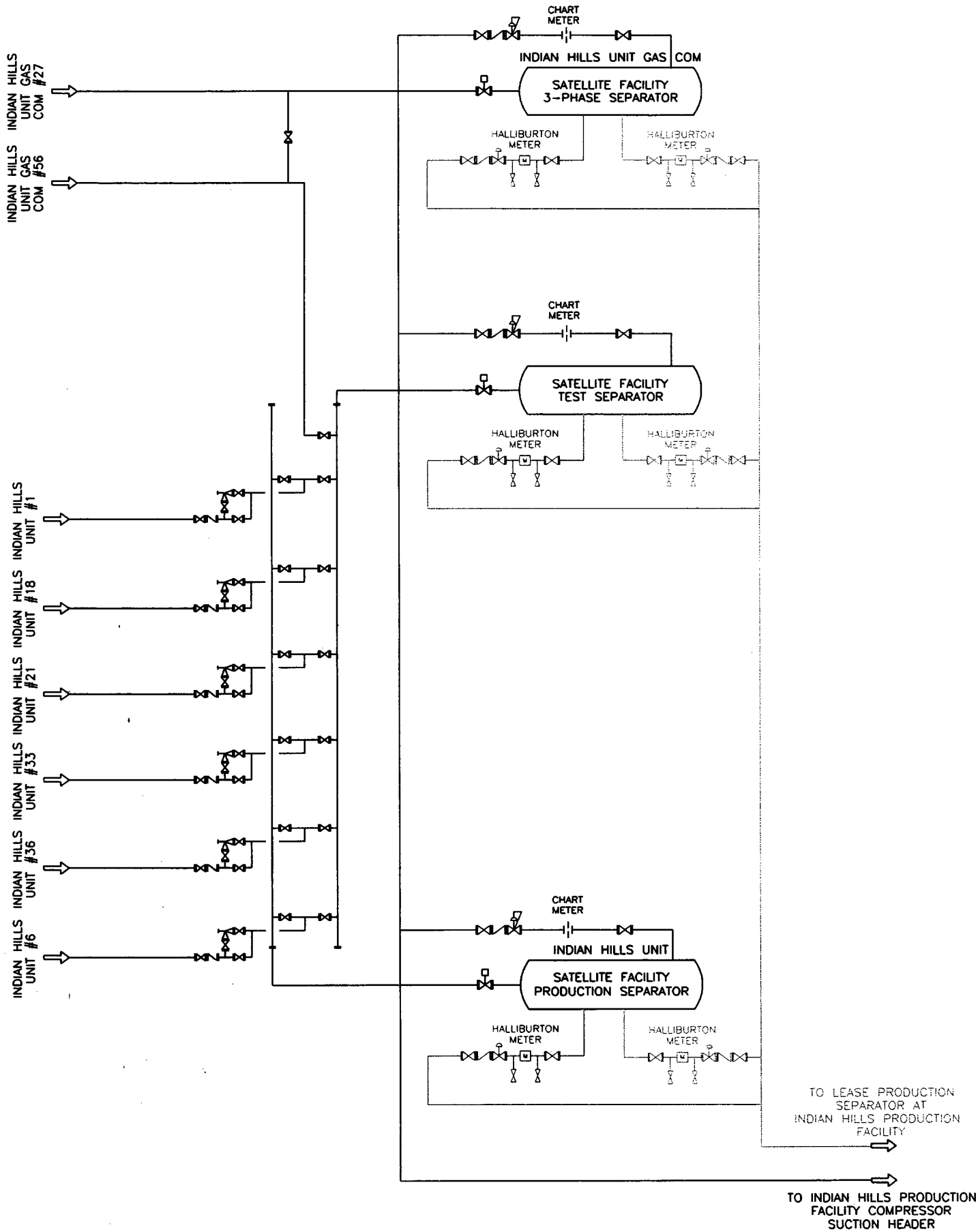
