- 6/4/07 Pumped 250 sx Thixotropic and 100 sx "C" with additives. WOC. Drilled through cement and circulated hole clean.
- 6/23/07 Set 7" 26# L-80 J-55 casing at 8798'. Cemented stage 1 with 150 sx Super "H" + 0.4% CFR-3 + 0.5% Halad + 0.1% HR-7 + 1#/sx Salt (yld 1.67, wt 13). Cemented stage 2 with 100 sx Super "H" + 0.4% CFR-3 + 0.5% Halad4-344 + 1% HR-7 + 1#/sx Salt (yld 1.67, wt 13). Tailed in with 100 sx Class "H" (yld 1.18, wt 15.6). Tested casing to 1500 psi for 30 min. WOC 66 hrs 15 min. Reduced hole and resumed drilling.
