

8/27/03 Resumed drilling at 12:00 PM.

8/31/03 Set 9-5/8" 36# casing at 1820'. Cemented with 200 sx Thixotropic "H" with additives and 900 sx 35:65:6 "C" with additives. Tailed in with 200 sx "C" with additives. Cement did not circulate. Ran 1" cement to surface with 1125 sx "C" cement with additives. WOC 92 hrs 15 mins. Reduced hole and resumed drilling.
