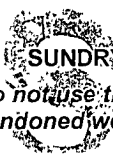

5-31-07 RU Bo Monk tbg tester. Test tbg BIH fine no hole, could have been tbg collar leak. RD tbg tester. Change tbg tools, to hook rods. RBIH pump, K-bars, rods, replace 26-K shear tool, replace 1-1" rod & tac 2-7/8" seat nipple, M&S load tbg w/27 bbls wtr, press to 500# psi hold good.
