Devon Energy Production Company, LP, respectfully requests approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake-Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in pre-approved pools or areas.

This pool was pre-approved by Division order PC-1108.

The San Andres is perforated at 1802-2123' and the Yeso is perforated from 2977-3315'.

Average production from the SA is 17 oil and 65 gas. Average production from the Yeso is 15 oil and 109 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 46.9% and gas is 62.6%.

For the San Andres formation, oil is 53.1% and gas is 37.4%.

Commingling these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.

The BLM has been notified of this filing.
