4. Reset CIBP @ 6356' & perf Delaware 5800-20.
5. Acdz w/ 1200 gals 7-1/2% acid. Frac if warranted.
6. PUH to 5700' and perf Delaware 5284-5304
7. Acdz w/ 1200 gals 7-1/2% acid. Frac if warranted.
8. PUH to 5184 and perf Delaware 4953-66
9. Acdz w/ 1000 gals 7-1/2% acid. Frac if warranted.
10. Combine all Delaware zones.
