Devon Energy Production Company, LP is applying with the NM OCD for approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in pre-approved pools or areas. This pool was pre-approved by NM OCD Division order PC-1108.

The San Andres is perforated at 1900-2187' and the Yeso is perforated from 3048-3408'. Average production from the SA is 9 oil and 32 gas. Average production from the Yeso is 11 oil and 49 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 55.0% and gas is 60.5%. For the San Andres formation, oil is 45.0% and gas is 39.5%.

Commingle these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.
