BEPCO, L. P. respectfully requests permission to recompleate this wellbore as a Delaware oil producer. It is currently TA'd in the Twin Mills (Atoka) field.

BEPCO seeks to set a CIBP @ 7850' and dump bail 35' of cmt on top for a PBTD of 7815'. The Delaware will be perfered at 7633-7639', 7644-7648, 7518-7523' & 7527-7532' w/ 1 JSPF for a total of 20 holes.

The new perfs will be acidized with 4000 gallons 7 5% NEFE Acid & fractured w/ 107,500 gallons Produced Water and 10000# 14/30 LiteProp 125.

A string of 2-7/8" production tubing will be RIH with SN @7700' and TAC five joints above the top set of perfs. The well will be returned to production.
