

TD & Production Csg - Drld 7-7/8" hole to 8150'. TD reached @ 07:00 hrs 09/10/07. Logged well w/ Halliburton. Ran 195 jts 5-1/2" 15.5# & 17# J-55 LT&C csg. Cmt'd 1st stage w/ 600 sks CI C + add. Circ 223 sks to surface. Cmt'd 2nd stage w/ 650 sks CI C. Circ 171 sks to surface. Cmt'd 3rd stage w/ 300 sks 65:35 POZ C followed by 200 CI C + 1% CaCl2. Circ 80 sks to surface. Test csg to 2500# ok. Ran CBL 09/22/07.
