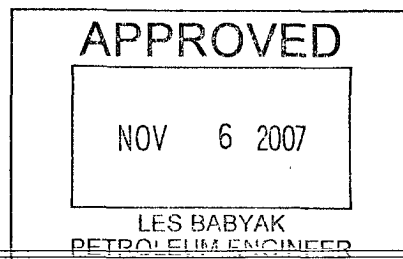

BEPCO, LP respectfully request permission to temporarily plug back the Morrow formation @ 11,850 to 12,223' by setting a CIBP in the tail pipe of a packer to be set @ ~11,820'. The Atoka formation will then be perforated at 11,110 to 11,372' with approximately 87 holes. The formation will be stimulated if necessary and the well put on production as an Atoka producer.

After a period of production to establish well test data, a downhole commingle permit will be sought to produce the wellbore from both the Morrow and the Atoka formations
