- 10.18.07 Pressure tested casing to 1000 psi for 30 minutes.
- 10.22.07 In 12-1/4" hole, ran 9-5/8" 40# J-55 LTC to 2742.'
- 10.23.07 Cemented with lead of 925 sx Interfill C + 0.125# Poly-e-flake (wt 11.9, yld 2.45) and tail of 200 sx Premium Plus + 1% CaCl2 (wt 14.8, yld 1.34). Circulated cement to surface. Pressure tested casing to 1000 psi for 30 minutes. WOC 31.75 hours.
