SD, wash to pit & drop landing plug. Did not bump plug. Circulated 101 sxs cmt to surface-full returns throughout cmt & displacement. FC @ 10,864', marker jts. @ 10,377' & 10,273', ACP (pkr) @ 1,654' & DV Tool @ 1,653'. On 12/30/2005, DN BOP, center pipe & set w/180K on slips, made rough cut on 5-1/2" csg & set BOP out to side. NU dry hole tree, jet & clean mud tanks. Release Nabors Drlg. Rig # 142.
