1/17/08 RIH to tag. No tag. Spotted 30 sx cement at 1690' and WOC. Tagged at 1768'. Spotted 50 sx cement at 1690' and WOC.
1/20/08 Tagged at 975'. Perforated at 798' and pumped 140 sx cement. WOC. Tagged at 965'. Re-spotted 100 sx thru perms at 798' and WOC. Perforated at 150'.
1/21/08 Tagged at 650'. Re-spotted 50 sx cement with LCM and 2% CaCl2 and WOC. Tagged at 650'. Pumped 100 sx cement and circulated to surface. Fell back and WOC. Tagged at 158'. Circulated 20 sx cement to surface. Fell back and WOC.
1/22/08 Tagged at 107' and called BLM. Pumped 30 sx cement. No circulation. WOC. Pumped 15 sx cement to surface. Fell back and WOC. Pumped 15 sx cement to surface and stayed full. Cut off wellhead. Installed dry hole marker.
