1/22/08 - Tag cmt @ 126'. Drill out cmt from 126' - 385'. Test sqz to 1000#.  
1/23/08 - Sqz csg leak @ 385' w/ 150 sx cmt.  
1/24/08 - Tag cmt @ 53'. Drill out cmt from 53' - 402'. Test sqz to 500#.  
1/25/08 - Drill out CIBP @ 3518'. RIH to 4378'. POOH. Lay down work string. Contact Richard Inge w/ OCD regarding pkr test.  
1/29/08 - RIH w/ plastic coated tbg & nickle plated R-4 pkr. Set pkr @ 4068'. Test pkr & csg to 300# for 30 min. Lost 10# during test.
