BEPCO, L.P. respectfully requests an extension of time to file a remedial cement plan for the subject wellbore. Completion operations for the well have been delayed due to the completion of the Big Eddy Unit Pipeline now under construction. The well has been perfered in the Morrow but cannot be tested until approximately June 1st when the pipeline is completed. At that time, BEPCO desires to test the Morrow for one month and then perforate the Atoka and test for three months. If production is adequate without further completion operations, the two zones will then be commingled and produced simultaneously.

From an engineering prospective, we feel that it would be more prudent to perforate and frac all production zones without subjecting squeezed perforation in the remedial cement zone to fracture and stimulation pressures. After the Morrow and Atoka zones are producing, BEPCO will file a remediation plan and procede to improve the integrity of the wellbore. We anticipate that the timing of that work would be around September 15th or October 1st, 2008.
