Cementing 8-5/8": 696 sacks Lead (yield=1.95) and 200 sacks Tail (yield=1.34). TOC @ surface with 100% excess. (60% excess)
Cementing 5-1/2" - Stage 1: 262 sacks Lead (yield=2.04) and 100 sacks Tail (yield=1.4). DV Tool @ 5100' with 25% excess. (21% excess)
Stage 2: 140 sacks Lead (yield=2.04) and 100 sacks Tail (yield=1.32). Top of cement @ 3120' with 25% excess. (54% excess)

Actual cement volumes for 5-1/2" casing to be determined by openhole caliper log.
