1/11/08 Frack Premier w/ 35800 lbs 16/30 sand carried by 943 bbls gel.

Install wireline RBP @ 3250' and perforate Penrose formation 2912-23', 3 spf

Frack Penrose formation w/ 53,480 lbs 16/30 sand carried by 1113 bbls gel.

After swabbing most of the load, 2 7/8" tubing was run with seating nipple set at 3495'. 3/4" rods were run and the well was put on pump. The Irvington, Premier and Penrose zones are commingled down hole.
