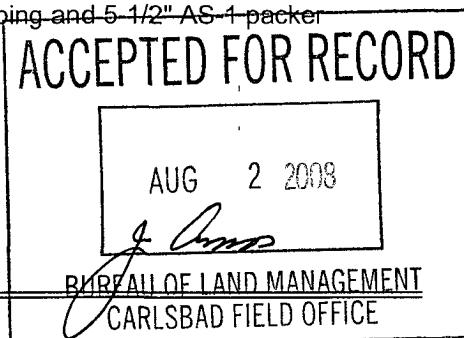
6/24/08 Perforated Morrow 8464'-8466' (18). Acidized with 500g 7-1/2% Morrow type acid.

6/30/08 Frac Morrow 8420'-8506' with 68,000g 40# x-link and 58,000# 20/40 Sinterball.

7/6/08 Re-frac with 68,000g 70Q CO2 foam and 67,000# 20/40 Sinterball. 2-7/8" tubing and 5-1/2" AS-1 packer with 2.25" on/off tool at 8160'.
