8-19-08 - DN WH & take rubber of NU screw on flange unset pkr & NU BOP, start POH tbq and pkr RU tbq tester, Test 101 jts BIH w/pkr 5 1/2 AD 1 pkr. Replace 2 jts 2 3/8 tbq ipc, set pkr @ 3186 RD Tbg tester, RU pump truck, press to 500 psi held good for 30 minutes, unset pkr.

8-20-08 - RU pmp truck, DN catch pan & shut in BOP circ 85 bbls pkr fluid, set pkr @ 3186' press to 500 psi for 30 min, held good, RD PU.
