Comments on Inspection: Drilling pit open. Liner breached in several areas. Well drilled in 2006. Debris (50 gallon drum, 5 gallon bucket, etc.) in pit. Some fluids in pit at time of this inspection. Large amount of fluid including oil were observed in this pit in June 2008. A closure proposal has been submitted and approved by OCD. Closure proposal is for onsite trench burial. Samples are to be obtained of pit contents (to determine if trench burial will be allowed) and submitted for analyses per 19.15.17 [NMAC] not later than 10/21/08. Analyses are to be submitted to NMOCD for review immediately upon completion by lab. At this time, this pit is in violation of previous pit Rule 50 and current pit rule 19.15.17[NMAC]. NMOCD District 2 office is to be notified 48 hours prior to obtaining samples.

Comments on Inspection: Met on site with Brian Novasak w/BLM. Pulling unit and reverse unit on site preoaring to drill out cmt plugs. Just ran back in hole-tagged @ 2012'. Preparing to resume drilling ops. Drilling pit has layer of oil covering over 50% of pit area. Violation 19.15.17[NMAC] (Pit Rule). Oil is to be removed immediately. Advised Carol Shanks w/McKay Oil via phone conversation 10/6/08. No oil absorbent boom was located on location. Violation 19.15.17[NMAC] (Pit Rule). Oil absorbent boom is to remain on lpcation until pit is closed. Please notify NMOCD District 2 office when violations are corrected, but not later than 10/21/08.

Comments on Inspection: Inspected site with BLM rep, Brian Novasak. Drilling rig on well. Currently RIH to resume drilling. Drilling pit liner has been breached in numerous areas. Large patches have been done on liner on inside walls. Violation 19.15.17[NMAC] (Pit Rule). Pits are to be constructed and maintained in such a manner as to prevent damage to liner. In the event a liner is breached, the NMOCD is to be notified immediately. No oil absorbent boom on site. A release has occurred outside the pit on the discharge side, not reported to OCD. Pit area was not properly prepared prior to lining as rocks have protruded through lining in several areas. Pit is to be brought into compliance with 19.15.17 [NMAC] not later than 10/21/08.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Divison Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.
