9/7/08 Resumed drilling at 10:00 PM. (Spud)
9/8/08 Set 13-3/8" 48# H-40 casing at 415'. Cemented with 150 sx Class "C" + 4% D20 + 2% S1 + 0.2% D46 (yld 1.98, wt 12.9). Tailed in with 200 sx Class "C" + 2% S1 (yld 1.34, wt 14.8). Cement did not circulate.
17 1/2 Ran temperature survey and found TOC at 210'. Ran 1" cement to surface with 200 sx Class "C" Neat. Tested casing to 600 psi for 30 min. WOC 63 hrs 40 min. Reduced hole to 12-1/4" and resumed drilling.
9/11/08 Set 8-5/8" 24#, 32# J-55 casing at 1010'. Cemented with 100 sx RFC spacer + 9.4#/sx D53 + 0.125#/sx D130 + 3#/sx D42 + 94#/sx D901 + 1.88#/sx S001 (yld 1.62, wt 14.2) and 220 sx Class "C" + 5.64#/sx D20 + 3.183#/sx D44 + 0.188#/sx D46 + 94#/sx D903 + 1.88#/sx S001 (yld 1.97, wt 12.9). Tailed in with 200 sx Class "C" + 2% S1 (yld 1.34, wt 14.8). Cement did not circulate. Ran 1" cement to surface with 230 sx Class "C". Tested casing to 600 psi for 30 min. WOC 42 hrs 30 min. Reduced hole to 7-7/8" and resumed drilling.
