13 Describe Proposed or Completed Operation. Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. If the proposal is to deepen directionally or recompleat horizontally, give subsurface locations and measured and true vertical depths of all pertinent markers and zones. Attach the Bond under which the work will be performed or provide the Bond No. on file with BLM/BIA. Required subsequent reports must be filed within 30 days following completion of the involved operations. If the operation results in a multiple completion or recompleat in a new interval, a Form 3160-4 must be filed once testing has been completed. Due to being unable to get below 1,065', we now propose the following:

1. Set cement plug from 1,065' to 725' with 420 sacks Class "C" + 2% S1 (yield = 1.34) mixed at 14.8 ppg.
2. Wait on cement.
3. Verify cement at 725' (recement as necessary).
4. Set cement plug from 60' to surface with 60 sacks Class "C" + 2% S1 (yield = 1.34) mixed at 14.8 ppg.
5. Cut off wellhead and install dry hole marker.
