Dear Operator;

A review of well records for your company indicates you have five (5) wells on the inactive well list which is in violation of the provisions of OCD Rule 19.15.4.201 which states in part "...A well shall be either properly plugged and abandoned or placed in approved temporary abandonment in accordance with these rules within 90 days after:

- (1) a 60 day period following suspension of drilling operations;
- (2) a determination that a well is no longer usable for beneficial purposes; or
- (3) **a period of one year in which a well has been continuously inactive."**

To prevent further enforcement action one of the following actions must occur;

1. Well must be returned to beneficial use within 30 days.
2. If well has been inactive for less than 7 years, the well may be placed in approved temporary abandon status. This requires submission of a notice of intent to temporary abandon within 15 days with a subsequent report of request for temporary abandonment and proof of mechanical integrity within 30 days of approval.
3. If well has been inactive for more than 7 years, a notice of intent to plug and abandon must be submitted within 15 days with the final abandonment notice submitted within 90 days of approval.
