BEPCO, LP respectfully requests permission to temporarily zone abandon the Morrow formation @ 12200-12384' by setting a 10 K CIBP in the packer tailpipe. The Atoka formation will then be perforated @ 11496-11674' and acidized with 2000 gals 7.5% NEFE HCL and put on production for the Atoka only.

After a period of production to establish well test data, a downhole commingle permit will be sought to produce the wellbore from both the Morrow and the Atoka formations.
