Spudded well on 11/18/08. Drilled 12-1/4" hole to 450'. Set 8-5/8" 24# J-55 csg @ 439'. Cmted w/375 sx (506 cf) cl "C" cmt w/2% Cacl2 & 1/4# C/F. Circ 75 sx cmt to pit. On 11/20/08, pressure tested 8-5/8" csg to 2000 psi for 15 min - OK.

Drilled 7-7/8" hole to TD3600' on 11/25/08 & set 5-1/2" 17# J-55 production csg @ 3590' w/PBTD @ 3549'. Cmted w/350 sx (627 cf) 35/65 POZ "C" cmt w/6% Cacl2, 5% salt, 0.2% FL-200, & 1/4# super flake & tailed w/400 sx (532 cf) cl "C" w/0.2% CD-20, 0.2% FL-200, & 1/4# super flake. Circ 25 sx cmt to pit. Released drilling rig on 11/26/08. Plan to pressure test 5-1/2" csg during completion operations.
