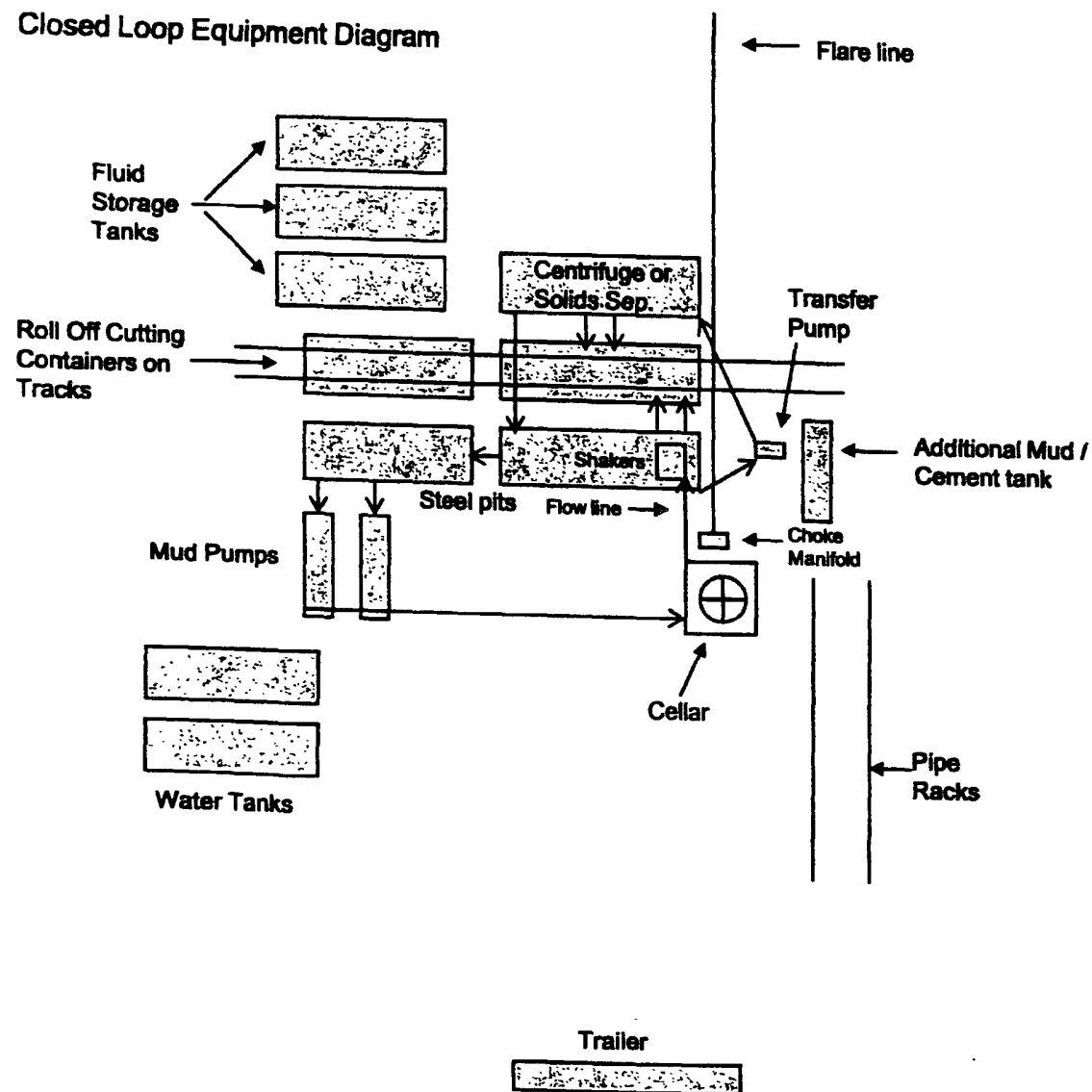

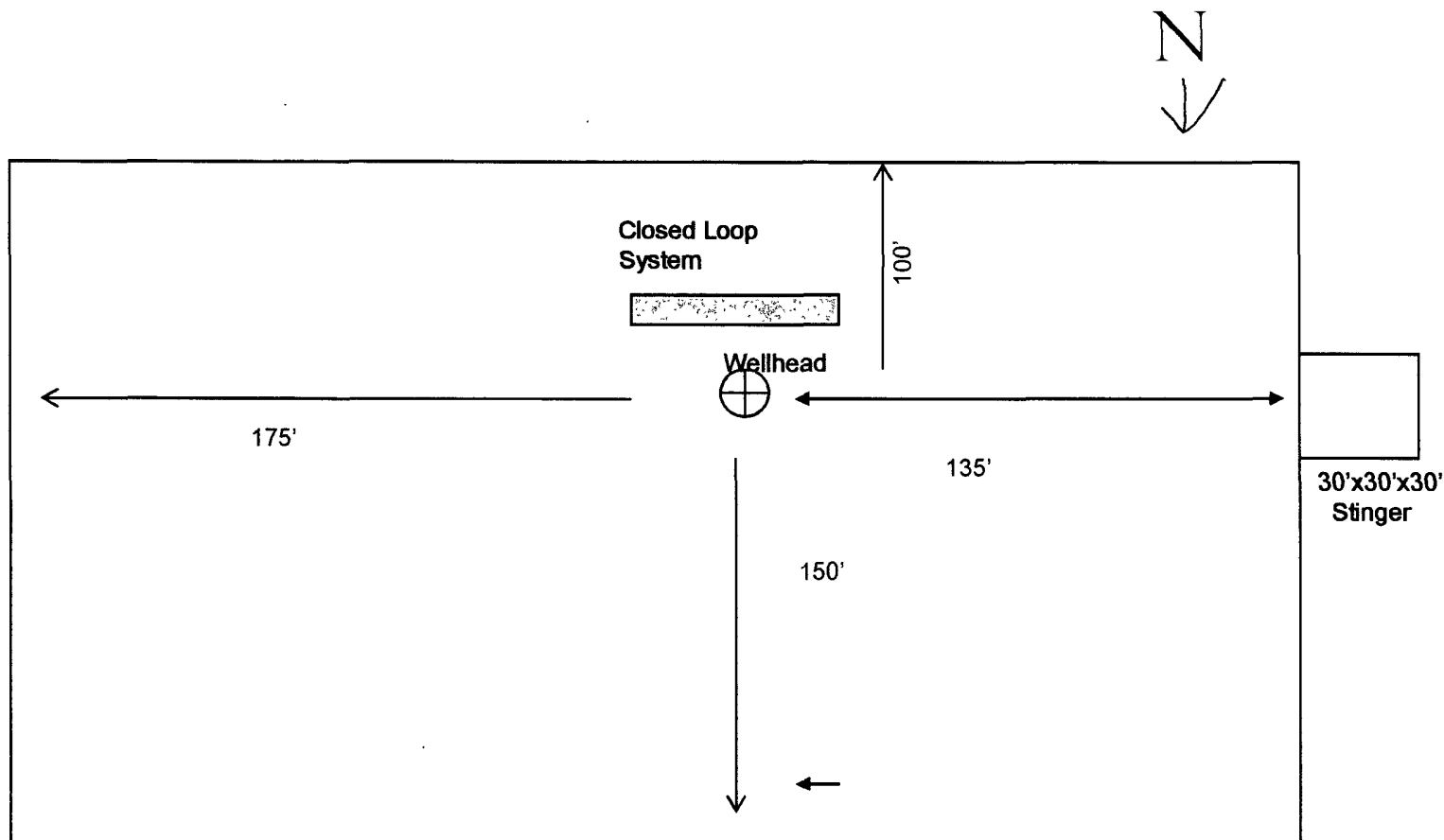

Closed Loop Equipment Diagram





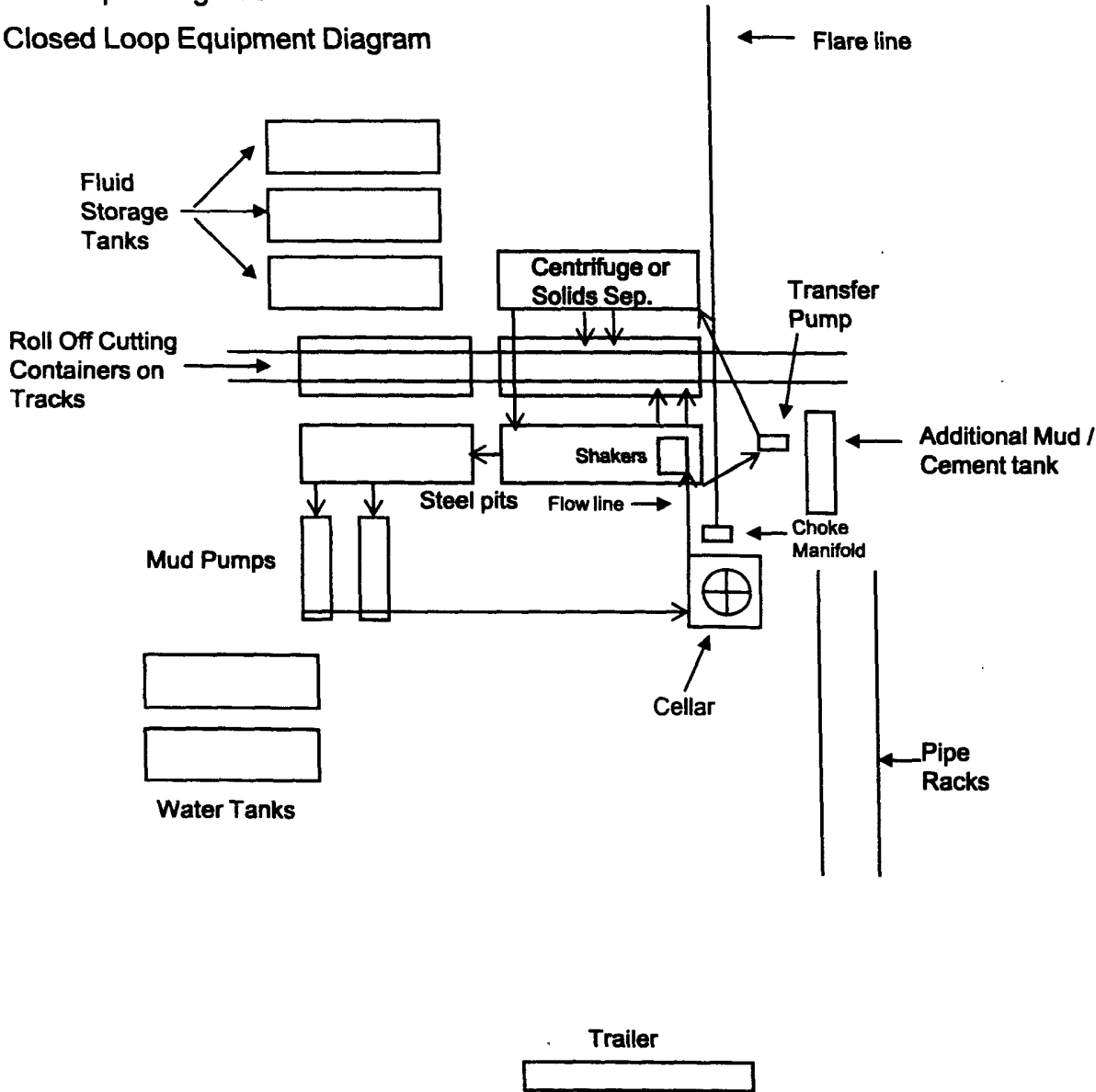
